The manual is an introduction and overview of participation in the federal Stafford student loan programs. It is designed to help train new financial aid and student loan personnel and to assist in answering questions about federal regulations. Federal Student Aid (FSA) Handbook https://fsapartners.ed.gov/ home/	A multi-volume annual publication produced by ED that provides detailed information about administration of the Title IV federal student aid programs and institutional eligibility to participate in these programs.	The FSA Handbook for the three most recent award years can be accessed by scrolling down to the <i>Handbook</i> section and clicking <i>Current Handbook</i> . For prior years, click on <i>Archives</i> .
FinAid www.finaid.org	FinAid was established in the fall of 1994 as a public service. The site has grown into a comprehensive online collection of information regarding student financial aid. Access to FinAid is free for all users and there is no charge to link to the site.	You can access information regarding scholarships, loans, savings, military aid and more directly from the home page. For specific information geared toward financial aid administrators and educators, click the <i>FAA's/Educators</i> button at the bottom of the page.

The home page has links to several topics. If you dont see what you are looking for, you can use the <i>Search</i> and <i>Advanced Search</i> functions on the left side of the page.	
Library of Congress Legislative Information – THOMAS http://thomas.loc.gov	The leadership of the 104th Congress directed the Library of Congress to make federal legislative information freely available to the public.	The THOMAS home page contains a search box for bill text (the full text of legislation) for the current Congress. Users can search by keyword or bill number (e.g. S. 1932). If you know the number of the bill you are searching for, type it in the box, select <i>bill</i> <i>number</i> and click on the search button. You will be linked directly to the text of the bill, or if there is more than one version of the bill, to a list of those versions.	
National Association of Student Financial Aid Administrators (NASFAA) www.nasfaa.org	National organization of financial aid professionals that provides information about regulatory and statutory changes, and sub regulatory guidance, along with comprehensive analysis of industry trends.	The NASFAA search feature allows users to customize Web searches based on keywords, categories and/or date published. Note: Many of the features and functions on the NASFAA website are for members only.	
National Center for Education Statistics (NCES) http://nces.ed.gov	NCES is the primary federal entity for collecting and analyzing data related to education. Its publications include: The Condition of Education, The Digest of Education Statistics and Projections of Education Statistics.	The NCES home page offers a <i>What's New</i> section, as well as tabs to information such as <i>Publications and Products, Surveys</i> and <i>Programs, Data and Tools</i> and <i>School Search</i> .
